

## INSTRUCTIONS FOR AUTHORS

### Author Guidelines

Authors must submit their papers via email to **brain@edusoft.ro** or they can create an account and submit their papers online, at **www.brain.edusoft.ro**. Submitted paper must be written in DOC format (Microsoft Word document), as clear and as simple as possible English. Preferred maximum paper length for the papers is 20 pages, including figures.

The text is single-spaced; uses a 12-point Times New Roman font; employs italics, rather than underlining (except with URL addresses); and all illustrations, figures, and Tables are placed within the text at the appropriate points, rather than at the end. The title will be bold 14-point, and the author will be 12-point italic. Figures have caption in bottom-center side, and Tables have captions in left-top side. Use a tab for indenting each paragraph and the subtitles, too. The subtitles will be bold 12-point. Please use Microsoft Word.

We encourage the authors to use the camera ready format even for the first submission. All paper submissions will be carefully reviewed by an editor, and by the members of the scientific board or independent experts, who will provide a written feedback with comments and ratings. Authors will be notified of acceptance in maximum 3 weeks. Accepted manuscripts should be revised according to the comments of the reviewers and of the editors.

### Submission Preparation Checklist

As part of the submission process, authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that do not adhere to these guidelines.

1. The submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).
2. The submission file is in Microsoft Word or RTF document file format.
3. Where available, URLs for the references have been provided.
4. The text is single-spaced; uses a 12-point font; employs italics, rather than underlining (except with URL addresses); and all illustrations, figures, and Tables are placed within the text at the appropriate points, rather than at the end.
5. The text adheres to the stylistic and bibliographic requirements outlined in the Author Guidelines, which is found in About the Journal.
6. If submitting to a peer-reviewed section of the journal, the instructions in Ensuring a Blind Review have been followed.

### Ensuring a Blind Peer Review

To ensure the integrity of the blind peer-review for submission to this journal, every effort should be made to prevent the identities of the authors and reviewers from being known to each other. This involves the authors, editors, and reviewers (who upload documents as part of their review) checking to see if the following steps have been taken with regard to the text and the file properties:

1. The authors of the document have deleted their names from the text, with "Author" and year used in the references and footnotes, instead of the authors' name, article title, etc.
2. With Microsoft Office documents, author identification should also be removed from the properties for the file (see under File in Word), by clicking on the following, beginning with File on the main menu of the Microsoft application: File > Save As > Tools (or Options with a Mac) > Security > Remove personal information from file properties on save > Save.
3. With PDFs, the authors' names should also be removed from Document Properties found under File on Adobe Acrobat's main menu.

Authors retain copyright and grant the journal right of first publication with the work simultaneously licensed under a Creative Commons Attribution License that allows others to share the work with an acknowledgement of the work's authorship and initial publication in this journal.

Authors are able to enter into separate, additional contractual arrangements for the non-exclusive distribution of the journal's published version of the work (e.g., post it to an institutional repository or publish it in a book), with an acknowledgement of its initial publication in this journal.
